

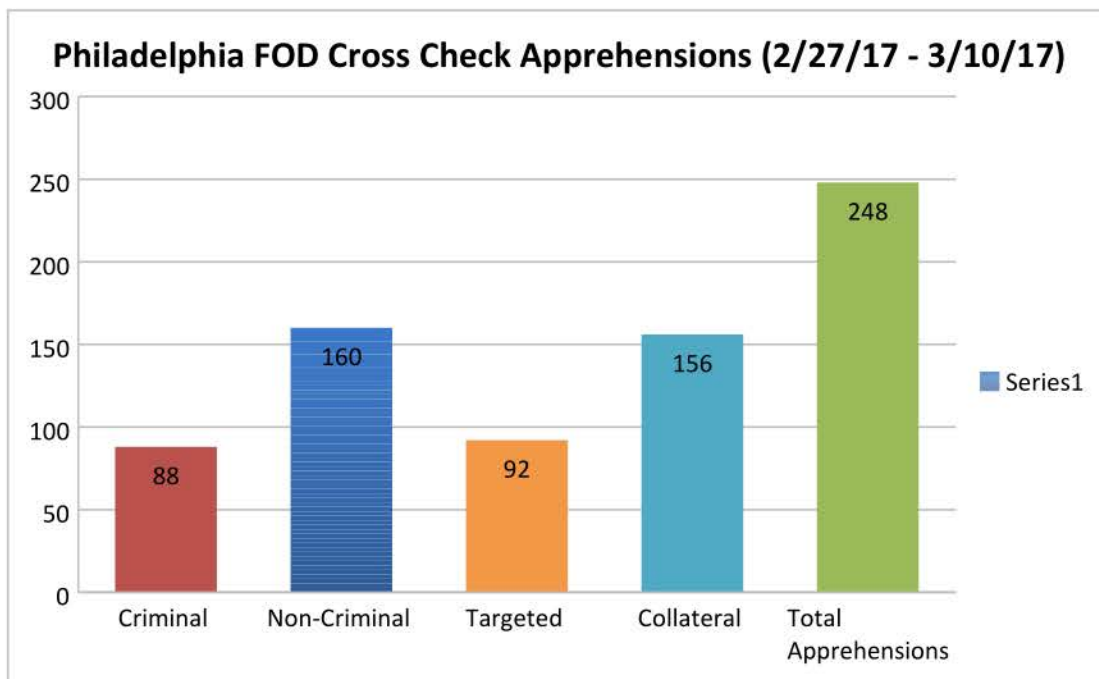

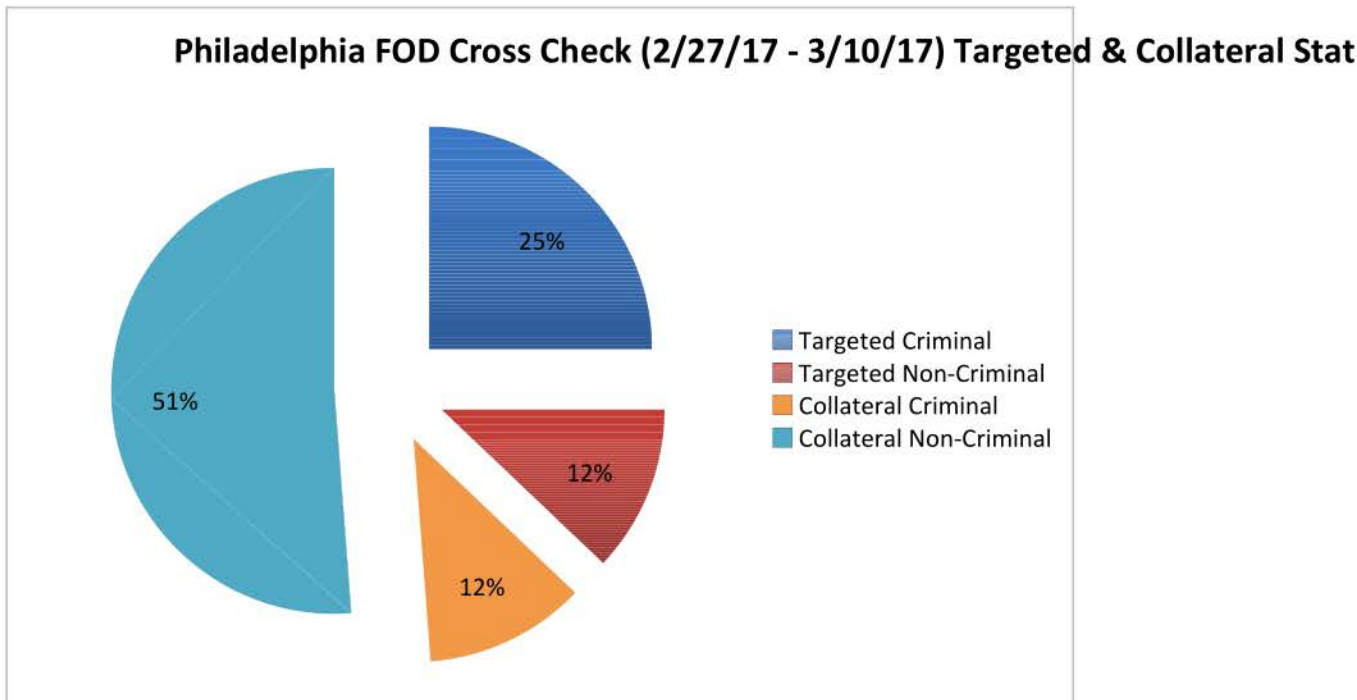
General

The Philadelphia Field Office held a Field Office wide Operation Cross Check from February 27th, 2017 through March 10, 2017. The Operation yielded the following results:

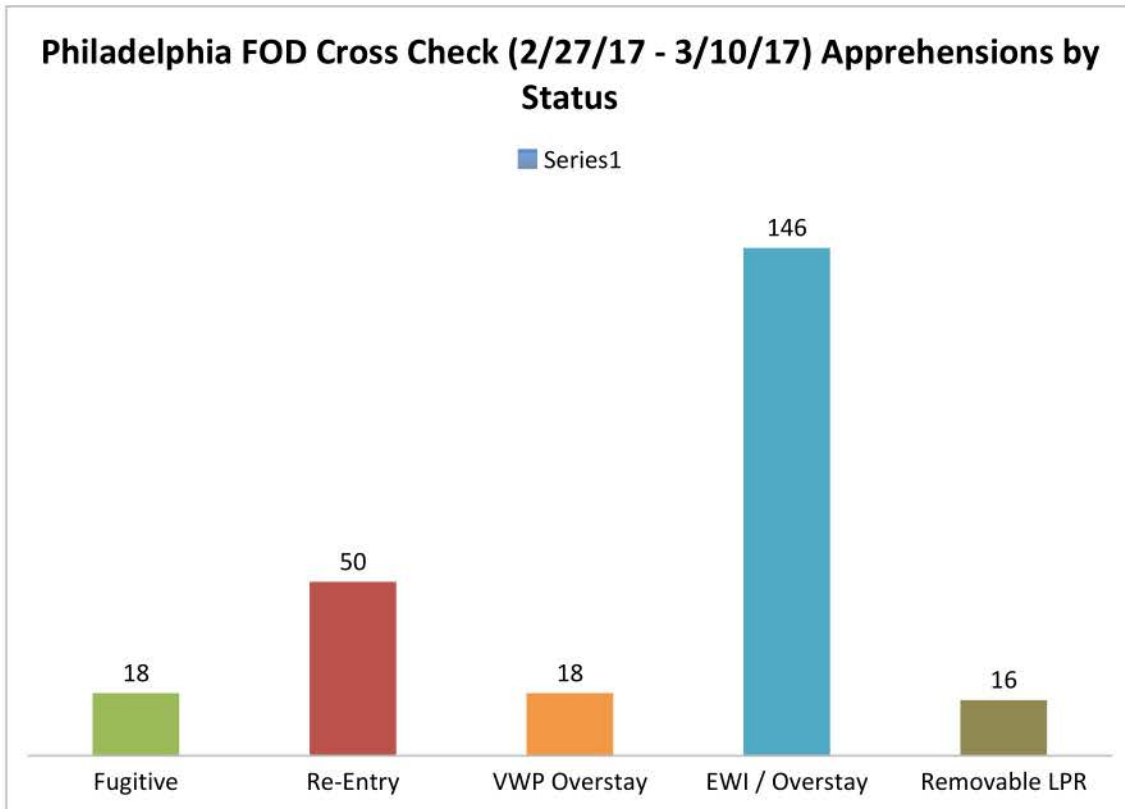

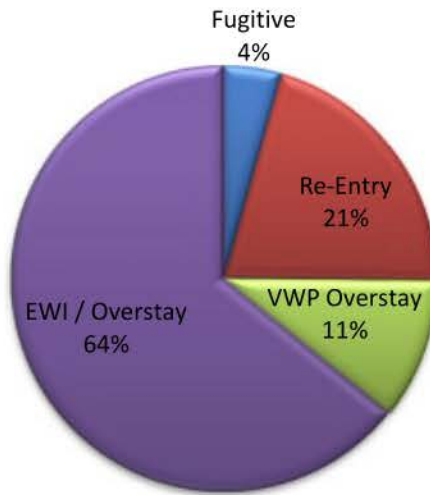

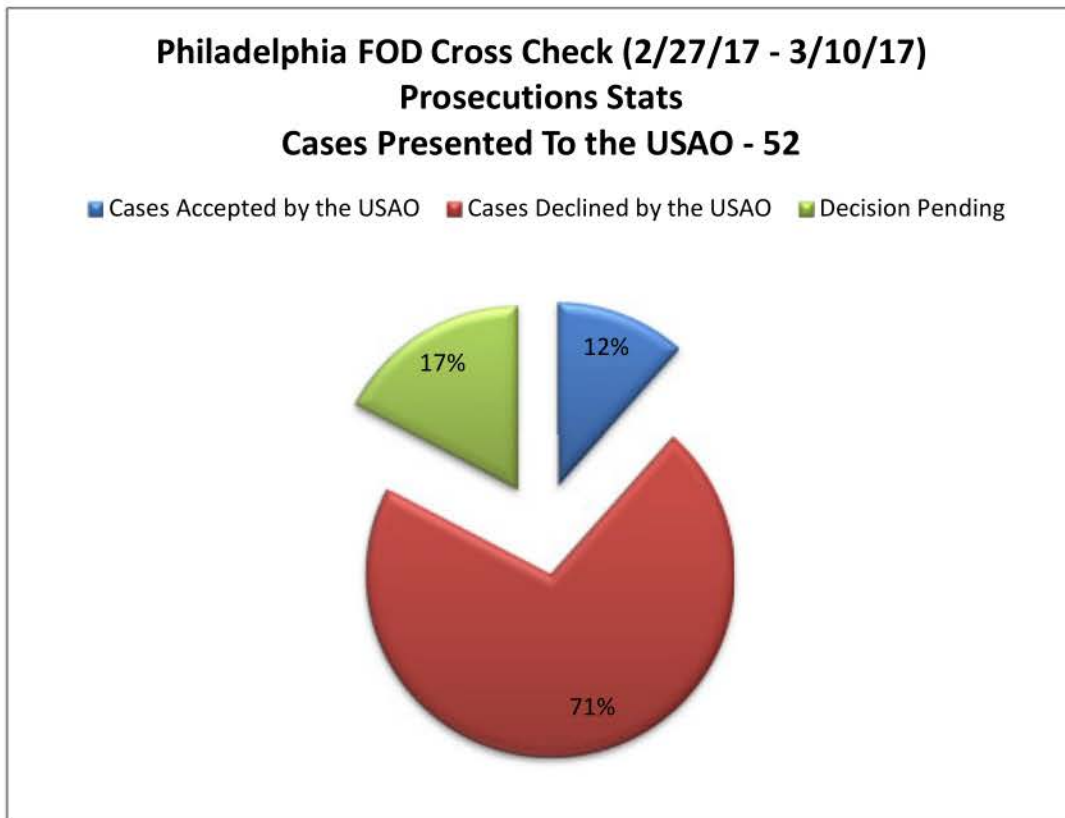
